## **FRIULANO IN CORTO**

### **A COMPETITION FOR THE PRODUCTION OF SHORT FILMS**

#### **OBJECTIVE:**

To promote and shoot a story about the excellence of winemaking in the region Friuli Venezia Giulia, through family stories, local expertise and techniques, land and wineries, in order to encourage videomakers to get to know the region and to narrate stories about its territories.

"**Wine and Roots**" is the main theme to be developed for this upcoming edition.

A financial contribution of 500,00 Euros will be awarded to 10 selected videomakers among all of the submitted projects, while the winner of the competition will receive an award of 3,000,00 Euros.

#### **RULES**

##### **PARTICIPANTS**

The competition is open to individuals or groups of videomakers who are legally residents in Italy, Austria, Slovenia and Croatia.

##### **PRE-SELECTION**

Electronic submissions should be sent to [friulanoincorto@buri.it](mailto:friulanoincorto@buri.it) no later than

May 5<sup>th</sup> 2015, and should also include the following material:

- a signed copy of these REGULATIONS for acceptance
- a fully completed information form
- a copy of a valid identity document (limited to one applicant in case of a group submission)
- CV
- a link to a showreel and/or to the most representative productions

A maximum number of 10 individuals or associated video-makers will be selected by May 9<sup>th</sup> 2015: they will be notified of their admission to the second phase of the competition by email or telephone

## **WORKS**

- The pre-selected videomakers will produce an original video, without any genre limitations, of a 6 to 8 minutes length;
- "Wine and Roots" is the official theme;
- The product must not contain or show any commercial brand or people names;
- The shooting must take place within the administrative boundaries of the Region Friuli Venezia Giulia
- The entire production will be made during the days following the official communication to the candidates of their admission to the competition.
- The shooting format will be Apple ProRes or DNx HD and must reach the Pro Loco offices by the June 5<sup>th</sup> 2005
- Foreign language films must have either Italian or English subtitles, .srt or .stl formatted
- Any liability regarding the product contents will solely reside with the author only and not with the Organisers or the Jury
- Incomplete or unreadable material will be automatically excluded from the competition
- The Organisers will not be liable for any damaged, stolen or missing works

## **JURY**

A quality jury formed by film experts and institutions representatives will be in

charge to evaluate and judge the submitted works and will assign the prize to the best film.

## **AWARDS**

- Upon submission of the videos a prize of 500,00 Euros will be assigned to each of the first 10 pre-selected videomakers; associated groups will be considered as a single participant;
- On June 14<sup>th</sup> 2015 at Villa di Toppo Florio in Buttrio all of the submitted videos will be shown and the winner of the prize of 3,000 Euros will be announced.

## **VIDEOS EXPLOITATION AND COPYRIGHT**

With the signed acceptance of these REGULATIONS the participant agrees on the following:

- to be the sole author of the video submitted to the competition 'Friulano in Corto';
- to be the sole beneficiary of the video copyright, including pictures and soundtrack;
- that all the individuals appearing and/or portrayed in the video have given their consent to the treatment of their personal data as per D.Lgs. 196/2003, including any sensible one, in line with the finality of the competition;
- that all the individuals appearing and/or portrayed in the video have given up the reproduction, distribution and exploitation rights of their image to the Author of the product;
- that all the individuals appearing and/or portrayed in the product will not claim any exploitation right or any economic benefit from the video;
- the Participant also declares not to hold the Organisers liable of any dispute or responsibility which may arise from a third party;
- each Author is fully liable of the contents of the submitted video and explicitly authorise its use and publication;
- the Participant authorises the 'Pro Loco Buri' and its appointed representatives to publish pictures and/or news regarding his/her video on daily, weekly and monthly magazines, for the promotion of the competition event;
- With their participation to the competition all Authors agree to include the caption 'Produced with the contribution of ERSA' together with the ERSA logo in the video credits;

- the Author agrees to promptly inform ERSA and the Organisation of any further screening of his/her video in order to allow them to participate and to be promoted under their specific channels;
- the Author allows the 'Pro Loco Buri' an all-use-right of his/her video waive in advance any claim of economic compensation from its non commercial use of Pro Loco Buri, Municipality of Buttrio, Autonomous Region Friuli Venezia Giulia and ERSA for their institutional, communication and promotional activities, it being understood that the Author will keep the rights of property and use of his/her video, including the right to be quoted as his/her Author.
- The Author explicitly forbids the use of his/her video within any context that could prejudice his/her dignity and explicitly relieving 'Pro Loco Buri' from any responsibility arising from any inappropriate use of his/her video from a third party.

## **PRIVACY**

- It is here furthermore stated that as per art.11 of D.Lgs. N 196/03 (Privacy Code) all videos and CVs submitted for the competition will be retained by 'Pro Loco Buri' to be used according to the objectives and purposes of these REGULATIONS and can be publicised for the performance of the activities set under these Regulations.
- The candidate explicitly authorises the 'Pro Loco Buri' and its direct delegates to the treatment of his/her personal data as per art.11 of D.Lgs. N 196/03 (Privacy Code), including the acquisition in their data banks;
- Any personal data, the uploaded videos or movies made by the Organisation during an event and meant to promote the Authors or the Organisation itself, will be used by the Organisation without necessarily request the authorisation of the other parties.

Any dispute, controversy or claim arising out of or relating to the competition 'Friulano in Corto' will be submitted in Italy to the Italian Law.
